Meeting Minutes: Regular Board Meeting

July 22nd, 2024

Meeting convened on Zoom at 5:04pm

1. Housekeeping & Governance:

- a) Bob motioned, Sam seconded, and the board unanimously voted to approve the June Meeting Minutes and July Agenda without changes.
- b) Ed went over the B1 Report. Vanessa motioned, Molly seconded, and the board unanimously voted to approve the report as given.

2) General Manager's Report:

- a) Financial update:
 - i) Ed went over the B1 Q2 financials report.
- b) Other Topics:
 - We've begun accepting donations to support local farms damaged in the recents storms. We've received a few requests so far and we intend to collect donations until August 3rd.
 - ii) I'd like to have an ad hoc committee meeting August 5th at 4:00 to help decide how to distribute those donations, anyone interested?
 - iii) There is a volunteer work day scheduled at Joe's Brook Farm Wednesday July 24th from 1-4:00, we'll pay employees interested in attending.
 - iv) The week of July 4th was our 3rd biggest week ever. We had records in Produce, Prepared Foods and Beer. We also had a record customer count hitting 8,000 for the first time.



- v) We have the opportunity to buy some CDFA state tax credits from The Colonial Theatre. I propose that we spend \$10,000 to purchase \$7,500 worth of those tax credits.
- vi) Our Member's Choice Awards have started, be sure to vote online for your favorite local products.
- Vii) I have been sitting in on meetings between Caledonia, NCG and potential architects. They are close to both applying to join NCG and selecting an Architect.
- viii) CFC elected new Board Members and have a new President and Treasurer in place, if you're interested in reaching out to your peers.
- ix) The warm and humid July weather has triggered some chronic refrigeration problems throughout the store. We're dealing with them as they pop up.
- x) We recently installed a Bicycle Repair Station next to the Pavillion bike rack. This was initiated by a Bike Friendly Business Association that we have joined.
- xi) I have reached out to Copper Cannon Camp to reserve their building for our Board Retreat on September 21st. They have a conflict but the 14th & 28th are available. We could also change venues.
- xii) We had an excellent turnout for the Chamber Players event on Thursday. Great Music with tasty wine & cheese samples made for a successful event.
- xiii) We have our Annual Veterans Event scheduled for 7/23 from 11-2:00.
- xiv) Our always popular Brewfest will be in our Cafe Saturday 7/27 11:30-4:00.
- xv) Becky will be chaperoning our Farm Tour on 8/21. Details to follow.
- xvi) I've started the 2025 budget, it will be a 53 week year and we're expecting sales to exceed the \$20 million mark.
- xvii) Our Insurance Company TRG will be presenting at our August Board Meeting to review their self insurance options. We'll provide materials prior to the meeting.
- xviii) The NH Farm to School Pilot Program Bill was signed into law recently, we hope to encourage some local participation.
- xix) I placed a copy of the NCG Board Bulletin in the Packet. Morrisville, Vt & Wolfeboro, NH are new members to NCG.
- xx) I am putting a B1 report for Q2 in the drive but will likely add or adjust numbers as they are finalized.
